# **SOFTBALL PROGRAM WAIVER & RELEASE**

## **IMPORTANT INFORMATION**

The Itasca Park District is committed to conducting its recreation programs and activities in a safe manner and holds the safety of participants in high regard. The Itasca Park District continually strives to reduce such risks and insists that all participants follow safety rules and instructions that are designed to protect the participants' safety. However, participants and parents/guardians of minors registering for this program must recognize that there is an inherent risk of injury when choosing to participate in recreational activities.

You are solely responsible for determining if you or your minor child/ward are physically fit and/or adequately skilled for the activities contemplated by this agreement. It is always advisable, especially if the participant is pregnant, disabled in any way or recently suffered an illness, injury or impairment, to consult a physician before undertaking any physical activity.

## **WARNING OF RISK**

Softball is intended to challenge and engage the physical, mental and emotional resources of each participant. However, despite careful and proper preparation, instruction, medical advice, conditioning and equipment, there is still a risk of serious injury, including but not limited to head/brain injury, back/neck injury, and bone and joint injury. Understandably, not all hazards and dangers can be foreseen. Certain risks include, but are not limited to, being struck by the ball, slip and falls, running into stationary objects and field fixtures such as backstops and home run fencing, poor technique, collisions with other players, uncontrolled pursuit of the ball, improper techniques for sliding on the dirt, fatigue, surface defects and irregularities, unsafe equipment, carelessness, poor conditioning, overexertion, poor sportsmanship, inadequate supervision or officiating, horseplay and all other risks inherent to softball. In this regard, it must be recognized that it is impossible for the Itasca Park District to guarantee absolute safety.

## **WAIVER AND RELEASE OF ALL CLAIMS AND ASSUMPTION OF RISK**

Please read this form carefully and be aware that in signing up and participating in this program/activity, you will be expressly assuming the risk and legal liability and waiving and releasing all claims for injuries, damages or loss which you or your minor child/ward might sustain as a result of participating in any and all activities connected with and associated with this program/activity (including transportation services and vehicle operations, when provided).

I recognize and acknowledge that there are certain risks of physical injury to participants in this program/activity, and I voluntarily agree to assume the full risk of any and all injuries, damages or loss, regardless of severity, that my minor child/ward or I may sustain as a result of said participation. I further agree to waive and relinquish all claims I or my minor child/ward may have (or accrue to me or my child/ward) as a result of participating in this program/activity against the Itasca Park District, including its officials, agents, volunteers and employees.
